



Employee Privacy Notice

This privacy notice has been written to inform prospective, current, and former employees of High Tunstall College of Science, about how and why we process their personal data.

Who are we?

High Tunstall College of Science is a 'Data Controller' as defined by Article 4 (7) of GDPR. This means that we determine the purposes for which, and the manner in which, your personal data is processed. We have a responsibility to you and your personal data and will only collect and use this in ways which are compliant with data protection legislation.

The college has appointed Veritau Ltd to be its Data Protection Officer (DPO). The role of the DPO is to ensure that the college is compliant with GDPR and to oversee data protection procedures. Veritau's contact details are:

What information do we collect and why do we need it?

The college require your personal information, and sometimes your special category data, in order to fulfil requirements set out in both your employment contract and by employment legislation.

The personal data we collect about you includes:

- Personal identifiers (your name, address, date of birth etc)
- Previous job experience and qualifications (including copies of certificates and employment references)
- Information about your employment attendance and performance (including disciplinary information)
- Information about your ethnicity
- Information about your right to work
- Relevant medical information which affects your employment
- Emergency contact information of those individuals you identify

- Financial information, including bank account information, tax, national insurance and pension contributions to facilitate salary payments
- Disclosure and Barring Service details

We process your information for the reasons outlined below. This is in order to fulfil our obligations associated with your employment in line with Article 6 (1)(a) and Article 9 (2)(b) of GDPR:

- Contractual requirements
- Employment checks e.g. right to work in the UK
- Salary requirements

Photographs

Staff photographs for use of identification purposes on our management information system and ID badges are not processed based on consent. We will seek your consent to use your photo for marketing purposes and on the college website. Please note that you can withdraw this consent at any time.

Who has access to your personal data?

Your information will only be made available to those who need it to do their job in relation to your employment. This includes your line manager(s), and relevant administrative staff.

Your name, job title and work email address will be accessible to all via the college website.

Who do we share your personal data with?

We will share your information with the following organisations:

- HM Revenue & Customs
- Department of Work and Pensions
- Pension Fund/Teachers' Pensions fund
- Any salary sacrifice arrangement you sign up to e.g. a charity
- Your trade union
- Examining bodies
- Payroll administrator – Hartlepool Borough Council
- Disclosure and barring service to conduct criminal record checks
- Prospective future employers, landlords, letting agents, or mortgage brokers where you have asked them to contact us to seek a reference
- National College for Teaching and Leadership

We have duties under the Freedom of Information Act 2000 to disclose information we hold unless there is a very good reason to withhold it. Therefore we may disclose your name and work email address publicly in response to a request if we are required to do so.

The college also has a specific duty (section 537A of the Education Act 1996) to share your information with the Department of Education for the purpose of the annual school census.

How long do we keep your personal data for?

High Tunstall College of Science will keep your data in line with our Records Management Policy. Most of the information we process about you will be determined by statutory

obligations. Any personal information which we are not required by law to retain will only be kept for as long as is necessary to fulfil our organisational needs.

Do you transfer my data outside of the UK?

Generally the information that the college holds is all held within the UK. However, some information may be held on computer servers which are held outside of the UK. We will take all reasonable steps to ensure your data is not processed in a country that is not seen as 'safe' by the UK government. If we do need to send your data out of the European Economic Area it will ensure it has extra protection from loss or unauthorised access.

What rights do you have over your data?

Under GDPR, individuals have the following rights in relation to the processing of their personal data:

- To be informed about how we process your personal data. This notice fulfils this obligation
- To request access to your personal data that we hold, and be provided with a copy of it
- To request that your personal data is amended if inaccurate or incomplete
- To request that your personal data is erased where there is no compelling reason for its continued processing
- To request that the processing of your personal data is restricted
- To object to your personal data being processed

If you have any concerns about the way we have handled your personal data or would like any further information, then please contact Ms Emma Watson, Senior Teacher at the college or alternatively our Data Protection Officer on the address provided above.
